AT4 is the allocative component of the Reference Tariff, and is levied on a nt basis;

AT5 is the electric access component of the Reference Tariff, and is levied on a egtk basis;

EC is the electric energy component of the Reference Tariff, and is levied on a egtk basis.

QCA Levy recovers the fees imposed by the QCA on the beneficiaries of its regulatory services.

IE Pass Through Cost is determined in accordance with the 2017 Access Undertaking, cl 7A.3.4

gtk is the gross tonne kilometres, being the total gross weight (in tonnes) of the Rollingstock multiplied by the distance (in kilometres) of the

egtk is the electric gross tonne kilometres, being the total gross weight (in tonnes) of the Rollingstock multiplied by the distance (in kilometres) of the electric Train Service:

rtp is the number of Reference Train Services;

ntk is the net tonne kilometres, being the total net tonnes multiplied by the distance of the Train Service;

nt is the net tonnes, being the total gross weight of the Rollingstock when loaded, less the tare weight of the Rollingstock when empty.

Train Service(s) is deemed to be a one-way Train Service(s).

Notes:

Tariffs are consistent with:

- the Reset Schedule F Preliminary Values, approved by the QCA on 26 May 2023; - Electric Energy (EC) charges for 2023-24, approved by the QCA on 21 June 2023;

- QCA Levy variation, approved on 24 August 2023, effective billed from 1 September 2023; and

- QCA appproved GAPE and Newlands Pricing DAAU on 22 Feburary, 2024.

- Access holders will be billed on these tariffs from 1 March 2024.

The amounts of AT1, AT2, AT3, AT4, AT5, and EC are GST exclusive. An amount of GST will be added to the total calculated access charge.

All tariff components (except QCA Levy and IE Pass Through Cost) are rounded to two decimal places.
